**Bulk Collection:**

Burlington Township - "White goods" are picked up by Burlington Township Public Works every other Friday by appointment, not to be included in this contract. Normal household "bulk" collection will be considered part of this contract and will be collected with trash curbside. There is no limit on amount/size of normal household "bulk" collection.

Burlington City – "White goods" are picked up by Burlington City Public Works, not to be included in this contract. Normal household "bulk" collection will be considered part of this contract and will be collected with trash curbside. There is no limit on amount/size of normal household "bulk" collection.

**Container Collection:**

Burlington Township - Once a week. Area of containers determine day of pickup. Ex) Beverly Road Fire House – Thursday collection. Collection days are available on the Township’s website.

Burlington City- Twice a week currently on Tuesdays and Thursdays. Lowest Responsible Bidder may change the collection days of the containers for Burlington City if the City is given enough time to notify the Institutional sources of such change.
