An application is hereby made to permit the placement of a waste refuse container, commonly known as a roll-off dumpster or roll-off container on or along the above listed roadway.

It is agreed that any dumpster or container placed on or along the roadway shall be equipped with markers consisting of yellow reflective diamond shape panels having a minimum size of eighteen (18) inches by eighteen (18) inches. These reflective panels shall be mounted at the edge of the dumpster or container at both ends nearest the path of passing vehicles and facing the direction of oncoming traffic. These markers shall have a minimum height of three (3) feet from the bottom of the panels to the surface of the roadway. If approved, this permit shall be valid for a period of seven (7) days, and may be renewed by the approving authority for an additional seven (7) day period, but not to exceed more than thirty (30) days.

The applicant is responsible for any damage to the roadway or other property caused by the placement of the dumpster or container.

DUMPSTER RULES & REGULATIONS
& 2 YARD DUMP TRUCK RULES

THE FOLLOWING RULES AND REGULATIONS WILL APPLY FOR ALL DUMPSTERS AND 2 YARD DUMP TRUCKS. IF NOT FOLLOWED, THE DUMPSTER/TRUCK WILL BE DUMPED ON SITE.

****18, 33 and 40 YARD DUMPSTER IS FOR BRANCHES ONLY****

1. ASBESTOS CANNOT BE MIXED WITH ANY OTHER MATERIAL LOADED ON THE TRUCK. ASBESTOS SIDING AND/OR SHINGLES MUST BE PLACED IN HEAVY PLASTIC AND MARKED AS TO WHAT THE MATERIAL IS. ADDITIONAL FEE.
2. THE TAILGATE MUST BE LEFT AS IS WHEN THE TRUCK IS DELIVERED; DO NOT PLACE ANY DEBRIS ON TAILGATE. DO NOT PILE ANYTHING HIGHER THAN EXISTING SIDES OF DUMPSTER OR TRUCK.
4. ROOFING MATERIAL/ASPHALT SHINGLES, USUALLY CAUSE THE DUMPSETER TO EXCEED THE FEE.
5. **NO BAGGED OR LOOSE LEAVES OR GRASS OR BUNDLED LIMBS**
6. **NO** METAL, TIRES, COMPUTERS & COMPUTER PARTS, PAINT CANS - LATEX PAINT & OIL BASED PAINT CAN GO INTO THIS DUMPSTER. ALL THE ABOVE ITEMS **MUST** BE DISPOSED OF AT THE COMPOST SITE ON LAKE AVENUE. FURTHER INFORMATION CAN BE OBTAINED BY CALLING 239-5909.
7. IF THE DUMPSTER OR TRUCK EXCEEDS THE FEE WHEN DUMPED, A BILL FOR THE ADDITIONAL AMOUNT WILL BE FORWARDED TO THE PERSON/PERSONS WHO RENTED THE TRUCK.
8. IF A DUMPSTER/TRUCK LOAN HAS BEEN PAID FOR BUT NOT FILLED AT THE TIME OF PICKUP, NO REFUND WILL BE AFFORDED. (SPECIAL WEATHER CONDITIONS MAY PRECLUDE THIS RULE).
9. **DUMPSTER OR TRUCK WILL BE DELIVERED NO LATER THAN 3PM ON THE DAY OF EXPECTED DELIVERY!**
10. **DUMPSTERS INVOLVING PAYMENT MUST BE PAID FOR PRIOR TO DELIVERY. ONLY CASH, PERSONAL CHECK, OR MONEY ORDER WILL BE ACCEPTED; NO BUSINESS CHECKS OR CREDIT CARDS.**
